        - 1803B Acknowledgement from GBRA that Aquatic Life monitoring Event that was carried over to FY 17 schedule from FY 16 QAPP at station 13657, needs to be modified in QAPP if it will be monitored. Basin 18 TCEQ Assessor Bill Harrison suggests that this be removed from the CMS and not included in the revised QAPP until ongoing TCEQ standards revisions at this station are concluded.
        - TCEQ region 14 expressed the possibility of monitoring from a boat at a new station downstream of the Invista wastewater discharge mixing zone near the historical station 16579 in order to fill in current data gaps in assessment units of the CMS. Staff requested that a formal request for any new monitoring be sent to Melanie Edwards in TCEQ region 14.
