### Lead and Copper

### **Required Additional Health Information**

The La Salle WCID #1 receives its water from surface water diverted from the Guadalupe River and treated at the Port Lavaca Water Treatment Plant, operated by the Guadalupe-Blanco River Authority (GBRA) and blended well water from the Port O'Connor Improvement District.

A Source Water Susceptibility Assessment for your drinking water source(s) is currently being updated by TCEQ. This information describes the susceptibility and types of constituents that may come into contact with your drinking water source based on human activities and natural conditions. The information contained in the assessment allows us to focus source water protection strategies. #### **Furbidity**

Turbidity has no health effects. However, turbidity can interfere with disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses and parasites that can cause symptoms such as nausea, cramps, diarrhea and associated headaches. Turbidity is measured 6 times per day through grab samples and continuously through automatic on-line individual filter turbidity monitors.
