Background

- The San Marcos Watershed Initiative formed in 2012 to develop a Watershed Protection Plan (WPP) for the Upper San Marcos River. Led by The Meadows Center for Water & Environment
- Formerly a TDS impairment
- Upper San Marcos River WPP accepted by EPA & TCEQ in 2018
- City of San Marcos takes over as lead entity on WPP implementation

OUR MISSION

The Upper San Marcos Watershed Protection Plan (USMR) is a plan that seeks to reduce water resource concerns by addressing water quality and quantity issues in the Upper San Marcos River Watershed.






OUR VISION

Sessom Creek Stream Restoration & Sewer Line Rehab Project




- Phase 1 completed in May 2023
- Phase 2 to begin in Fall 2024. Project includes stream restoration, plant restoration & relocation of exposed sewer lines
- CoSM awarded \$120,000 FY24 CWA 319(h) grant through TCEQ NPS program



Downtown Alley Reconstruction Project

- Reconstruction of Kissing Alley and Jacks Alley in downtown San Marcos
- Project to include replacement of existing pavement with permeable paver surface & underdrain system
- Pilot project from the SM Green Alley Initiative
- CoSM awarded \$200k FY24 CWA 319(h) grant through TCEQ NPS Program



City of San Marcos Disposable Beverage Container Ban & Cooler Size Ordinance



- New ordinance prohibits the possession of single-use beverage containers in or on the San Marcos River within City limits and within designated portions of City parks
- Prohibits the use of coolers >30 qts on or in the portion of the SM River adjacent to City park property
- Ordinance will become effective May 1, 2024





- Ongoing projects include:
 - Mgmt of Recreation
 - TWR & Aquatic Plant Restoration
 - Litter Removal
 - Non-Native Species Mgmt
 - Riparian Restoration
 - Water Quality Protection
