The Guadalupe-Blanco River Authority (GBRA) is pleased to provide you with the 2024 Water Quality Report (January 1-December 31, 2024). We take all possible precautions to safeguard your water supply and hope you will be encouraged to learn about the high quality of water provided to you.

The Federal Safe Drinking Water Act (SDWA) requires water utilities to issue an annual report to customers, in addition to other notices that may be required by law. This report explains where your drinking water comes from, what it contains, and the health risks our water testing and treatment are designed to prevent.

We are committed to providing you with information about your water supply because informed customers are our best allies in supporting improvements needed to maintain the highest drinking water standards.

We are proud to report that the Texas Commission on Environmental Quality (TCEQ) has assessed our system and determined that your drinking water, meets or exceeds all federal and state water quality standards.

Information about your Drinking Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.

Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Contaminants may be found in drinking water that may cause taste, color, or odor problems. These types of problems are not necessarily causes for health concerns. For more information on taste, odor, or color of drinking water, please contact the system's business office.

You may be more vulnerable than the general population to certain microbial contaminants, such as Cryptosporidium, in drinking water. Infants, some elderly, or immunocompromised persons such as those undergoing chemotherapy for cancer; persons who have undergone organ transplants; those who are undergoing treatment with steroids; and people with HIV/AIDS or other immune system disorders, can be particularly at risk from infections. You should seek advice about drinking water from your physician or health care providers. Additional guidelines on appropriate means to lessen the risk of infection by Cryptosporidium are available from the Safe Drinking Water Hotline (800-426-4791).

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We are responsible for providing high quality drinking water, but we cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. In compliance with the 2021 Lead and Copper Rule Revisions, GBRA has conducted a comprehensive inventory of system service lines for the Lomas Water/Comal Trace Water System and have found no service lines of unknown status, containing lead, or galvanized steel in need of replacement. Where Do We Get Our Drinking Water?

The Lomas Water/Comal Trace received its water from two sources. Groundwater is pumped from the Trinity Aquifer and blended with surface water from Canyon Reservoir treated at the GBRA Western Canyon Water Treatment Plant, operated by the Guadalupe-Blanco River Authority.

TCEQ completed a source water assessment of your source water, and the results indicate that our sources have a low susceptibility to contaminants. The sampling requirements for your water system is based on susceptibility and previous sample data. Any detections of these contaminants will be found in this Consumer Confidence Report. Trained operators monitor and test the water, including the addition of chlorine, to ensure that our water meets or exceeds all state and federal drinking water standards. The treated water is delivered to the Lomas Water/Comal Trace water storage tank and delivered through its distribution system to you. What We Found

The following tables list the contaminants that have been found in your drinking water. USEPA requires water systems to test for more than 97 contaminants. The column marked "Highest Level at Any Sampling Point" shows the highest test results during the year. The "Source of Contaminant" column shows where the substance usually originates.

DEFINITIONS and ABREVIATIONS

Action Level (AL) – the concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.

Action Level Goal (ALG) – The level of a contaminant in drinking water below which there is no known or expected risk to health. ALGs allow for a margin of safety.

Avg – Regulatory compliance with some MCL's are based on running annual average of monthly samples.

Maximum Contaminant Level (MCL) – the highest level of the contaminant allowed in drinking water. MCL's are set as close to the MCLG's as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) – the level of a contaminant in drinking water below which there is no known or expected health risk. MCLG's allow for a margin of safety.

Maximum residual disinfectant level or MRDL – The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum residual disinfectant level goal or MRDLG – The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants. NA – Not Applicable

NTU's – Nephelometric Turbidity Units

pCi/L - picocuries per liter (a measure of radioactivity)

ppm – parts per million, or milligrams per liter (mg/L)

ppb – parts per billion (ug/L)

Level 1 Assessment – A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system

Level 2 Assessment – A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E.coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.

Turbidity

Turbidity has no health effects. However, turbidity can interfere with disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses, and parasites that can cause symptoms such as nausea, cramps, diarrhea, and associated headaches.
